I affirm that neither I, nor any member of my household, have traveled outside of the country or to any city considered to be a "hot spot" for COVID-19 infections within the past 30 days and not done the proper quarantining of 14 days or 7 days and a test. *see link at bottom of form for a map of those states and counties considered "safe"* Furthermore, I will immediately inform MLD and discontinue classes once I, or any member of my household, returns from traveling outside of the country or to any city considered to be a "hot spot" for COVID-19 infections.

I understand that MLD cannot be held liable for any exposure to the COVID-19 virus caused by any misinformation on this form or the health history provided by each Student.

MLD will adhere to the following enhanced procedures to prevent the spread of COVID-19.

Our instructors and staff will...

- Do a temperature check before entering the studio, and ensure that it is below 100°F.
- Clean/Disinfect frequently touched surfaces thoroughly and at regular intervals between classes.
- Wash/Sanitize our hands before and after each session.
- Wear masks at all times.
- Maintain a safe distance at all times.
- Schedule classes as to allow time for cleaning/disinfecting surfaces.
- Provide sanitizers in the reception area and other locations within the premises.

We are requesting that each of our students, please...

- Allow us to check their temperature before entering the premises to ensure it is below 100°F.
- Wear a face mask at all times within the building and within the studio.
- Use the hand sanitizer before entering and while exiting the studio.
- Wash hands frequently.
- Respect personal space of other students.
- Bring plenty of water to each class.
